***All exhibitors and family are invited to free bar-b-que Friday evening after the breeding gilt show.

Present registration papers on purebred entries at check-in.

Report declared weight to registration as early as possible within check-in hours. Ten (10) lb. weigh back will apply.

CDC is open to any youth 21 years old and younger as of September 1, 2019. Out of state youth are permitted to show. Only FJSC members will be eligible for overall circuit points. Exhibitor must be able to drive his/her own animal in the makeup area and show ring without any assistance.

Approximately 110 pens will be available on a first-come first-serve basis the day of show. Showing off trailers is encouraged.

Hog pens are concrete. Exhibitors are responsible for supplying shavings or rubber mats. No straw or hay will be allowed. Wash racks will be available on premise. Pen waterers are not provided. All exhibitors are responsible for cleaning pens prior to leaving barns.

All swine must have Certificate of Veterinary Inspection at the time of unloading. All out of state swine must also have a Florida permit/permission number on the health papers. In order to obtain a permit/permission number visit: <http://www.freshfromflorida.com/Divisions-Offices/Animal-Industry/Consumer-Resources/Animal-Movement/Swine-Movement-Requirements> , or your vet can contact the State of Florida veterinarian, Dole Conner, at (850) 410-0900. All health papers must be issued within 90 days of December 2nd.

It is recommended that all swine be vaccinated against Leptospirosis (6-way) including bratislava and erysipelas.

Electricity is limited on premise. Generators are permitted.

There is no limit to the number of animals exhibitors can show.

All pigs must have a permanent identification either in the form of readable ear tag or ear notches.

Substitutions will be accepted day of show.

Purebred breeding gilts will be shown by age and must be born after June 1, 2019.

Cross breeding gilts, prospect purebreds and prospect crossbreds will be shown by weight.

Gilts may enter both breeding gilt and prospect show.

Purebred breed divisions will be Duroc, Yorksire and All Other Breeds (AOB).

Maximum declared weight for all pigs is 250 lbs.

All purebreds must meet respective breed characteristics. **In all purebred divisions, award winners must present registration papers (digital or hard copy) prior to any awards or payouts being issued.**

Showmanship is open to all exhibitors. Exhibitors may use another hog with owner's permission.

Showmanship division/ages are as follows (as of 9/1/2019):

Novice - 8 and under Junior – 9-12 Intermediate – 13-16 Senior – 17- 21

All exhibitors must be neatly dressed including close-toed shoes. Official dress is not required.

Barrows and gilts only, NO boars will be allowed.

All top three (3) class winners will be weighed back before final class placing awarded. Prizes will be awarded to top (3) per division and top five (5) overall.

SUPREME CHAMPION Points

At the conclusion of showmanship the four (4) division winners (Novice, Junior, Intermediate and Senior) will compete for the title of Supreme Champion

The judge's decision is final in all classes.

Show officials reserve the right to make changes deemed to be in the best interest of the show.

All animals must be removed 2 hours following conclusion of the show.

The exhibitor and a parent or legal guardian must sign all entry forms.

The show committee, the Deland SR FFA, nor the Volusia County Fairgrounds will not be responsible for any accidents or injuries that occur.

The show committee, the Deland SR FFA, nor the Volusia County Fairgrounds will not be responsible for any lost or stolen personal items or damages to property.

Exhibitors must adhere to the FJSC Official Show Rules posted at www.fjsc.info

Entry fees: \$25.00 per head/entry, **postmarked by November 8th, 2019.**
 A late fee of **\$10.00 exhibitor applies to** entries postmarked after November 8th.
 Entries will be accepted the day of the show, EXACT CASH ONLY.
 Showmanship entry will be \$10.00 per exhibitor.
 All entries are non-refundable.
